APPLICATION

We need the application filled out completely. Be sure to give us any information that will make it easier to approve your application. If you fail to fill in all the information requested, it may result in a delay in your being approved. Please include a check for your membership dues, made payable to Indianhead, along with your completed application. Your application will not be considered if your dues check is not included with the application. You will need to select the membership classification that best suits your particular situation. Please read through the membership section, listed below, to make your selection.

APPLICATION PROCESS

Once your application has been received, it will be reviewed by the Indianhead Membership Chairman and then presented at the next Indianhead Board of Directors meeting. Once the Board approves your application, you will be notified by our Membership Chairman and will then be permitted to attend any meetings held by the Indianhead Photographers organization. It is understood that we expect an Indianhead member to make every effort to attend our meetings on a regular basis. The Indianhead Board meets prior to all regular Indianhead meetings.

INDIANHEAD MEETINGS

Indianhead meets the second Monday of the following months:

Jan., Feb., April, May, June, Oct. & Nov.

Note: We may have to change some dates on occasion due to other conflicts with seminars, conventions, other organizational activities, etc.

DEFINITIONS OF MEMBERSHIP

ACTIVE Membership may be extended to owners, partners or managers of portrait or commercial studios and is limited to one Active Member per business. Must hold a valid state Sales Tax Permit. An Active member has one vote, may hold office, may enter prints in competition and be awarded ribbons.

ASSOCIATE Membership may be extended to the immediate family of an Active member, or to persons employed by an Active member or Husband & Wife member. An Associate member has the same privileges of membership as an Active Member, except they do not have a vote.

HUSBAND & WIFE Membership may be extended to a husband & wife who own and both are involved in their studio. Must hold a valid state Sales Tax Permit. Each has the same membership privileges of membership as an Active Member, with one vote per studio.

SUSTAINING Membership may be extended to a person whose major interests are the distribution of photographic equipment or supplies or are members of a firm providing services to professional photographers. A Sustaining member may attend meetings, be heard, but has no vote.

LIFE or HUSBAND & WIFE LIFE Life memberships must be requested in writing by letter or email. You must meet the qualifications as spelled out in our By-Laws. If you have questions about Life membership, please contact the Membership Chairman.
